CHAIRMAN'S REPORT - BUSY FUTURE PLANS FOR NORA-SA

Leon van Dyk, Chairperson of NORA-SA addressed members and guests at the 12th annual NORA-SA AGM, held at the Birchwood Hotel and Conference Centre on Wednesday 14 June 2017. Van Dyk highlighted some of the main achievements and challenges NORA-SA over the past year and explained the organisations' plans going forward.

Achievements

Oil collections improved, with 2016 seeing 29 402 442 wet litres being collected, compared to 26 988 791 litres collected the previous year. This equated to R 6 314 847 million being paid out by the ROSE Foundation in 2016 in environmental incentives for dry litres collected.

"Stakeholders in the used oil industry were audited regularly throughout 2016, and the year saw a continuation of the Memorandum of Understanding and the excellent working relationship between ROSE and NORA-SA – something which is critical to success," advised Van Dyk.

"Hazchem, fire fighting, first aid, oil spill and business concepts training courses were once again presented in 2016 to equip collectors and processors. The EXCO also worked very hard to enhance its relationship with Local and Provincial Authorities as well as the National Legislature."

One of the biggest challenges always facing NORA-SA and indeed the entire industry is compliance with environmental legislation. "In 2016 the EXCO undertook actions to assist members with guidelines on permits, licenses, members compliance and code of conduct."

Challenges

Van Dyk advises that membership has shown a decrease compared to the previous year - which is of concern.

Maintaining membership numbers is an ongoing challenge facing the organisation and whilst it is recognized that all members of the used oil industry do not necessarily want to join NORA-SA, this is a problem that needs addressing by reminded members of the industry what the benefits of NORA-SA membership are, such as legal advice and government updates, public liability insurance and oil spill clean-up costs, training, audits, operation manuals, oil storage tanks at a subsidised price, access to bulking points and much more.

Way Forward

"Total estimated collected used oil volumes in South Africa is in the region of 80 million litres for 2016. It is anticipated that 50% of oil produced/ supplied into the market place is recoverable by NORA members," says Van Dyk. "It is ROSE and NORA's strategy to increase collection volumes to 40-50 million litres in the next year, and it is expected that a new incentive system, the establishment of bulking points and storage facilities in outlying areas, and ongoing assistance of collectors in being more efficient will contribute to larger collectable volumes in the industry."

Van Dyk explains that going forward NORA and ROSE plan to develop their relationship through the continuity of leadership and expand and build upon the MOU. "We plan to focus on retaining and growing membership through a targeted plan and to offer benefits and credibility which others can't."

"We will also continue to lobby Government to develop enabling and empowering legislation to support the industry

and we will continue to assist members with compliance, whilst at the same time implementing more stringent monitoring to ensure collectors do not to sell oil directly to end users or to non-compliant processors."

"We also hope to implement a strategy that sees the end users of used oils being audited where possible," concludes Van Dyk.

ROSE CHAIRMAN'S REPORT

Fabian Magerman (right), Chairman of the ROSE Foundation, addressed guests at the 12th annual NORA-SA AGM held in Johannesburg recently.

Magerman shared the good news that 2016 saw the highest wet and dry used oil volumes being collected by ROSE members since 2011. He also spent some time reminding those that attended about the roles and responsibilities of the ROSE Foundation and unpacked the strategy of the organisation going forward.

"The ROSE Foundation has been in existence since 1994, and since its inception has championed the collection of well over 1 billion litres of used lubricating oil. ROSE has now formulated a targeted strategy that supports the sustainability of the recycling economy," said Magerman.

"Our overriding focus for the next four years is to significantly increase the ROSE Foundation's footprint and influence in the used lubricating oil recycling value chain, thus meeting our stakeholders' expectations to ensure that ULO is recycled in a responsible and compliant manner," explained Magerman, who went on to advise that the ROSE Foundation's strategy going forward involved focusing on awareness, volumes, compliance, upliftment and trust.

"Our goal by 2020 is a to achieve a high level of awareness and positive perceptions among key stakeholders around the responsible handling of used lubrication oil and the role of the ROSE Foundation in the ULO recycling value chain. We also intend to significantly increase the volumes of recycled collectable used lubricating oils accounted for (by ROSE) within the recycling value chain, as well as to significantly



increase used oil can collections."

Magerman went on to say that ROSE's goal for compliance going forward is to have 80% of all collectable used lubricating oil in the South African market collected and recycled by NORA-SA members and other roleplayers associated with the ROSE Foundation and to increase the level of compliance of roleplayers (such as collectors and processors) within the used oil recycling value chain to 90%.

"With regards to our focus on upliftment in the next four years, ROSE will continue to support the upliftment of historically disadvantaged individuals in the used oil and related waste recycling value chain. The final "pillar" of our change strategy is that of trust and we plan to strengthen the perception among the Regulating authorities so that the ROSE Foundation is known as a trusted and effective body within the used oil recycling value chain."

We are confident of the success of ROSE's future and look forward to reporting back on the successes in the future," concluded Magerman.
