

## **Stakeholder Reawakening Workshops**



The ROSE Foundation conducted a series of "Reawakening Workshops" in four regions where collectors and processors operate. Stakeholders across the used oil industry were updated with developments, compliance, Government strategy, current challenges, and ROSE's supportive role and vision. CEO, Bubele Nyiba, highlighted several goals the ROSE Foundation was working towards:

- 1. Account for ALL recycled oil
- 2. Support the value chain players in a non-partisan way

3. Streamline our business process to reduce unnecessary paperwork and red-tape

- 4. Drive the industry towards a circular economy
- 5. Work with all stakeholders towards a common goal
- 6. Maintain a support not policing role
- 7. Influence legislation

Lihle Mqayi, Environmental Compliance Advisor outlined the support and benefits ROSE offered stakeholders, while Environmental Claims Administrator Tashriq Creighton, discussed the ROSE incentive requirements.

The workshops held in the Cape Town, PE, Umhlanga Rocks, Johannesburg, were all well attended and received positive feedback.

## **Claiming Incentives**

Collectors are asked to adhere to the following steps to ensure there are no issues with paperwork, and they receive the correct pay-outs in good time:

• Use ROSE manifest books for entering of collections and issuing Generators with waste manifests.

- Ensure that details are accurately and clearly filled in.
- Clearly, indicate which suburb & city the oil was collected from and taken to.

• Indicate if oils were delivered to a bulking point. **Note**: Bulking points cannot claim for oil brought by other collectors. Collectors deliveries to bulking points are deducted from bulking points schedule from the waste receiver.

• Claim incentives ONLY for used oils delivered to Licensed Waste Facilities.

• At every month end, Collectors must ensure that they receive or request a summary schedule of their deliveries to the processors or bulking points which they have delivered to, referencing which waste manifest slips are linked to which delivery.

• Collectors must also ensure that all waste manifest slips referenced on their deliveries schedule are sent to ROSE head office. Send the ROSE copies (page 5) from the waste manifest books.

**NB:** The ROSE Foundation holds all collector's generator details under strict confidentiality. No information is divulged to any party. We are particularly focused on the municipalities in which the generator is based for our volumes reports and to determine whether the collection would be at the 15c or 30c incentive rate.



## **Processors and Collectors**

The ROSE foundation would like to welcome SA Fuel & Combustion Supplies which has just been licensed.

They collect used oil and make use of a safe process to re-produce used oil to a burning fuel, which is used by the following industries; sand drying, slag drying, aluminium, and steel smelting, asphalt industries, lime drying industries, fertilizing industries etc. SA Fuel & Combustion Supplies is aware of the impact that used oil can have on the environment and has taken the necessary precautions by installing proper Burner equipment as well as heating systems to ensure proper combustion of fuel.
